### Technical Content – January 2023



- > Approved consolidating SPE's peer-reviewed papers into a single journal to improve citation impact for authors and expanded reading options for subscribers.
  - Starting in January 2024 all papers currently published in SPE Journal, SPE Drilling & Completion, SPE Production & Operations, and SPE Reservoir Evaluation & Engineering will publish online into a single monthly journal, SPE Journal.
  - > The new version of the journal will feature discipline specific sections. Each of the current specialized journals (DC, PO, REE) will have a representative section(s) within the new journal.
  - > The expanded SPE Journal will publish monthly issues (40–45 papers per issue) and will be available on OnePetro™
- > Approved increasing SPE member benefits to include free access on OnePetro to all SPE technical papers published prior to 1990.
- > Held a strategic discussion on reimagining and updating ATCE as SPE's flagship event.
- > Received a report from staff on planned increases to memberonly JPT content starting in 2023.
